Animal Adoption Agreement

My signature below indicates that I have read, and that I agree to enter into and fully abide by the terms and conditions of the Animal Adoption Agreement between me (herein referred to as "Adopter"), and the Cat Rescue Adoption & Foster Team (CRAFT) and its volunteers and foster care providers, for one or more cats/kittens (herein referred to as "animal") currently cared for by or on behalf of CRAFT. Adopter, upon approval of the adoption application and payment of the adoption fee/donation, adopts the follow animal(s) from CRAFT:

1. Adopter understands that animals available for adoption from CRAFT have been rescued from a variety of situations, including from feral cat colonies or other neglect/abuse situations and, as such, could be subject to illnesses, genetic disorders, diseases or other health and/or behavioral problems not known at this time. Adopter agrees to accept the animal with this understanding. **Initial Here:** _____

2. Adopter understands that CRAFT is not in a position to know, and makes no representations, warranties or guarantees with respect to the background, temperament, health or possible lifespan of the adopted animal, and Adopter agrees to accept the animal with this understanding. **Initial Here:** _____

3. Adopted understands that upper respiratory infections and fungal infections (ringworm and similar skin ailments) are common in shelters, clinics and multi-cat environments; and that even if the adopted cat/kitten appears to be free of such infection, a change of environment and the stress of a new home can trigger unknown medical conditions. Adopter agrees to accept the animal with this understanding. **Initial Here:** _____

4. Adopter releases CRAFT from any and all liability for any personal injury, property damage or any other losses caused by the animal adopted herein, whether such injury, damage or loss is caused to Adopter, members of Adopter's family, other animals under Adopter's care, or to any other person, animals or entity. Adopter further assumes the full risk of any such injury, damage and/or loss and the payment of any resulting liability.

5. Adopter understands and agrees to assume full responsibility for the health and welfare of the animal adopted for the duration of the natural life of the animal. This responsibility includes, but is not limited to, all costs incurred for veterinary and health needs, housing and shelter, food and any other expenses related to the care and welfare of the adopted animal. **Initial Here:** _____

6. Adopter understands and agrees to provide the animal adopted herein the following minimum conditions of care:

- a. Except where medically necessary and upon the recommendation of a veterinarian, the animal adopted herein will not be subject to any mutilation procedures such as (but not limited to) declawing.
- b. The adopted animal must, at all times, have appropriate housing and shelter facilities, food and health care. The greatest care must be given to assure the animal is not subjected to attack from dogs, cats, or wildlife.
- c. The animal adopted herein must, at all times, have adequate and suitable human companionship. The animal may only be isolated for the purposes of veterinary treatments and health care.
- d. Adopter must, at all times, treat the animal adopted herein with respect, and never willfully subject the animal to any type of abuse, neglect, suffering, abandonment or isolation. **Initial Here:** _____

7. Adopter agrees to contact a veterinarian within two weeks of adoption to schedule a wellness examination of the animal. It is understood that in most cases a fee will be charged by the veterinarian for the exam and any medical treatment, and the cost will be the adopter's responsibility. **Initial Here:** _____

8. Adopter agrees that if, for any reason, Adopter cannot keep or properly care for the adopted animal, Adopter will willingly surrender the animal to CRAFT or a CRAFT foster care provider and promises that the animal will not be surrendered to an unsuitable home or an animal shelter, unless the shelter is no-kill. If the animal is returned to CRAFT for any reason during the first ten days of ownership, the adoption fee or donation will be refunded to the Adopter. After ten days, CRAFT will gladly accept the animal for any reason, but the Adopter will not be entitled to a refund. Adopter will be responsible for transporting or any other costs incurred as a result of the return or release of the cat/kitten to CRAFT. **Initial Here:** _____
